Universley offers this Application, including all information, tools and services available from this Application to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

By visiting our Application and/or purchasing something from us, you engage in our "Service" and agree to be bound by the following terms and conditions, including those additional terms and conditions and policies referenced herein and/or available by hyperlink. These Terms apply to all users of the Application, including without limitation users who are browsers, vendors, customers, merchants, and/or contributors of content. In the event of an inconsistency between this Agreement and any additional terms or policies referenced herein, the provisions of the additional terms or policies shall control.

Please read these Terms carefully before accessing or using our Application. By accessing or using any part of the Application, you agree to be bound by these Terms. If you do not agree to all the Terms of this Agreement, then you may not access the Application or use any Service.
